Elections Code § 10229 states that if by the 88<sup>th</sup> day, during normal business hours as posted, prior to the day fixed for a regularly scheduled municipal election or the 83<sup>rd</sup> day before the election, during normal business hours as posted, if an incumbent fails to file pursuant to § 10225, no one or only one person has been nominated for any office that is elected the city elections official shall submit these facts to the governing body of the city and inform the governing body that it may adopt one of the following courses of action:
